

## **ACL/ACLAIMH Statement of Privacy**

ACL/ACLAIMH is committed to protecting your privacy. This Statement of Privacy applies to the ACL/ACLAIMH Web site and governs data collection and usage at all ACL/ACLAIMH sites and services; it does not apply to other online or offline sites, products or services. ### **Collection of your Personal Information**

ACL/ACLAIMH may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on ACL/ACLAIMH or the site; (b) protect and defend the rights or property of ACL/ACLAIMH, including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of ACL/ACLAIMH or the public.
